CHAIRPERSON'S CORNER

After our usual New Year's Thanksgiving Mass last January 3, 2023, we began to tackle and finalized our Budget for 2023 as well as our 5-year Development Plan that we will submit to our General Assembly to be held on the Third and Fourth Sunday of March 2023. We restated our vision by adding our target for additional members, assets and share capital. Our new Vision for the next 5 years will be "A World Class Financial Institution Committed to Serve with Regular Members of 147,000, Share Capital of P1.5 Billion and Total Assets of 7 Billion by year 2027". We know that this is tall order but we based our assumptions on our financial performance for the last 5 years.

We successfully held our 2-day General Assembly last March 19 and 26, 2023 at the school grounds of Sapang Palay National High School in San Jose del Monte City, Bulacan. We use the facilities of the school as our sports complex where we usually hold our General Assembly was not available and under repair.



Total attendance in our General Assembly reached 11,868 which is 80% of our total Members Entitled to Vote (METV). The usual agenda were discussed and all the reports of the Board of Directors, Management and Committees were presented to the attendees and these were unanimously approved by the members present. We have also some discussions on our 5-Year Development Plan which were also included in our printed Annual Report. The highlight of our Long-term Development Plan is our dream to have a new building in our 1,500 sq. m. lot in front of our current head office, the said lot is now occupied by Edesco Market stall holders. As reported to the General Assembly, there is a need to construct a new head office in as much as we expanded our operations thereby increasing our personnel and volume of transactions. We plan to convert our old building as a branch while the managerial staff including the office of the Board of Directors, Board Room, Executive Offices and training centers will be located at the new office building.

We also included in the Plan, our program of venturing in the commercial space leasing business which will be offered solely to interested member of San Jose Koop. We are now engaging an Architech who will conceptualize the new building. We told the General Assembly that we will prepare a project study on the commercial space leasing business to determine the no. of floors to be constructed. By March 2024, we will hold a referendum on the no. of floors that will be constructed on our 1,500 sq. m. lot. The referendum will be held as part of our General Assembly.

During the first quarter of 2023, we still have elevated inflation of 7%. We hope it will continue to drop to about 6% in the coming months. It is our feeling that we can still overshoot our target income and asset in the first quarter of 2023.

he General Assembly is considered to be the highest policy-making body of the cooperative and shall have exclusive power as stated in the cooperative code, bylaws and articles of cooperation of the cooperative. To provide excellent service to members is our top priority, thus they must be acquainted of the up-to-date operational activities and all undertakings of the cooperative through the general assembly meeting that only takes place once a year.


Recently, the San Jose Koop conducted its 33rd Sequential General Assembly and Election of Officers last March 19 & 26, 2023 at the Sapang Palay National High School in San Jose del Monte City, Bulacan, with the theme "Empowering Members' Financial Future". In order to accommodate mass of members attending this special event, we have been implementing the sequential GA meeting to be held for two different schedules.

Election of Officers was the first part of the event wherein all members entitled to vote has to select their candidate/s for each vacant position. Upon constituting the quorum we proceeded promptly to the meeting proper for the approval of proposals. A total of 14,753 Members Entitled to Vote (METV) were expected to attend the sequential general assembly meeting to exercise their rights as members of the cooperative. On March 19, 2023, there was a total of 5,674 attendees or 77% of the declared METV were present on the first schedule of GA. On March 26, 2023 a total of 6,013 attendees or 81% of the declared METV were present during the last schedule of general assembly meeting. There were also METV who were unable to attend on their schedule but counted in. To sum it up, 11,868 attendees or 80% of the Total METV took their best efforts and time to attend this significant event of the cooperative. We also gathered data for those Non-METV who attended the 2-day general assembly meeting, totalling a number of 2,473.

Furthermore, we also conducted an educational forum for members to impart and instill the importance of financial literacy and to make them fully participate in financial decision-making on a day to day basis. Through this short seminar, they will be able to secure and utilize their finances accordingly. Lastly, lots of raffle prizes were given away to all members who participated and voted during the meeting.

This remarkable event was a success because of the support and presence of each one of us. A warm congratulations to all members, officers, staff and newly elected officers of the cooperative!


FUNDAMENTAL OF COOPERATIVE

Last February 28, 2023 San Jose Del Monte Savings and Credit Cooperative sponsored a seminar entitled "FUNDAMENTALS OF COOPERATIVE" conducted by Ms. Ruby Salvador held at San Jose Koop training room together with some new employees and Koopdinators of San Jose Koop. She discussed the History of Cooperative, Cooperative Movement Milestone, Laws & Regulations, 7 Cooperative Principles, and Cooperative Values. We tackled the Powers of the General Assembly their Right & Duties as Members. One of the thing I liked as a co-op member was the Patronage Refund. Patronage Refund was one of the benefits offered by cooperatives. These were portion of profits earned by the Cooperative that the Board of Directors declares to give to the members in appreciation of their business and in accordance with the Cooperative's By-laws. It took 8 hours of listening and I would say, I had really enjoy every single moment and at the same time we learned a lot. It was indeed a great and memorable experience to be part of this seminar.

As an employee, attending and listening to seminars is so much important for us because it helps you become a better listener, present your arguments and ideas clearly and be open to others point of view. Group discussions and activities can also let you practice interpersonal skills, such as dealing with conflicting opinions among group members and working together to accomplish assignments or tasks. The other benefits of attending seminars are, improving your communication skills, gaining expert knowledge, networking with others and renewing motivation and confidence.

The most important thing that I've learned is that "Adhering to the cooperative principles is not a checklist nor is it a destination. Instead, living out the principles is a practice that we will need to continuously reflect on and develop as a cooperative.
